To the People of Oklahoma:

I am pleased to issue the July monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

Yields on U.S. Treasury securities were mixed at month-end with changes in the single digits. The difference between the two-year and 10-year Treasury yields narrowed to 236 basis points, the narrowest difference since May 20, 2008 as investors became more comfortable with buying longer-dated securities. Stocks climbed to a nine month high in July. The Dow Jones Industrial Average (DJIA) was up 8.6% for the month closing at 9,171. The S&P 500 gained 7.4% in July and has risen 34% in five months. The Nasdaq Composite jumped 7.8% and has risen 43% in five months. Federal Reserve Chairman Ben Bernanke appeared before the House Committee on Financial Services for his semiannual testimony on monetary policy. Bernanke acknowledged that signs of improvement in both financial market conditions and economic prospects had emerged in the last few months, as consumer spending stabilized, declines in home values moderated and contraction in the manufacturing sector eased. The Fed Chairman also provided details on tools available to unwind accommodative policy, but made it clear it will be an "extended period" before the Fed begins the tightening process.

Economic Developments

The Institute for Supply Management reported that its index of manufacturing activity continued to rise reaching 44.8 in June. This was the sixth straight monthly increase. The unemployment rate rose to 9.5% in June from 9.4% in May. This was the smallest increase since April of 2008. The median duration of unemployment surged to a record 17.9 weeks in June from 14.9 in May. The average workweek was reduced to 33 hours in June, an all time low. Retail sales rose by 0.6% in June, mainly due to higher gasoline prices. Despite this gain, retail sales fell 7.8% on a year-over-year basis. The overall consumer price index (CPI) rose 0.7% in June. Excluding food and energy, core CPI rose by 0.2%. The Commerce Department reported the trade deficit in May declined to \$25.9 billion, its lowest level since 1999 as foreign demand for U.S. products increased. The Conference Board's consumer confidence index fell to 46.6 from 49.3 in June. U.S. gross domestic product (GDP) contracted at a 1% annual rate for the second quarter, its slowest pace in a year. This was an improvement over the first quarter contraction of 6.4% and the fourth quarter of 2008 of 5.4%. Housing starts in the U.S. rose to an annual rate of 582,000 in June, a 3.6% increase from May, and the highest level since November 2008.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 3.31% in July and the weighted average maturity was 525 days. Following historical patterns, cash balances increased during July. As revenue collections continue to decline compared to the prior year, the year-to-date monthly average investable base was down \$328 million to \$3.524 billion. Portfolio diversification continues to be sound. U.S. Treasuries represented 7% of holdings, and U.S. government sponsored enterprises accounted for approximately 41%. Mortgage-backed securities were 22%, Municipal Bonds were 1% and Certificates of Deposit represented 6% of assets. Money market mutual funds were 8%, and 11% was maintained in overnight repurchase agreements. Link deposits (at less than 1%), State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on market conditions, portfolio strategy will consist of a combination of laddered maturities and market observation for investment opportunities.

Collateralization

All funds under the control of this office requiring collateralization were so secured at rates ranging from 102% to 110%, depending on the type of investment.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,542,260,900 and State Agency balances in OK Invest at \$1,802,780,843 for a total of \$5,345,041,743.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees, mutual fund operating expenses and fees charged by JPMorgan Chase for the Tri-Party Repurchase Agreement Program are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.



In February 2008, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2009. The amount estimated was \$146,500,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison July 31, 2009

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at Northern Trust ("Northern").

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



The State Treasurer participates in a Securities Lending Program with The Northern Trust Company ("Northern") acting as lending agent. Northern retains 25% of the revenues generated as compensation for services. Its share for the month was \$21,394.13. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$425,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
