To the People of Oklahoma:

I am pleased to issue the January monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

After a fourth quarter marked by rising yields across the U.S. Treasury curve, January saw a pronounced steepening. Inflation expectations were being priced into the long end of the curve. The last week of the month was overshadowed by unrest in Egypt. A flight-to-quality was evident as yields fell across the curve. The unrest in Egypt also sent U.S. stocks reeling. The Dow Jones Industrial Average (DJIA) fell 166 points to 11823.70, the largest one day drop since November 16, 2010. The Standard & Poor's 500 index (S&P) and the Nasdaq Composite Index (Nasdaq) both experienced the biggest one-day drop since August 11, 2010. The S&P fell 23.30 points to 1276.34 and the Nasdaq tumbled 68.39 to 2686.89. At the January meeting the Federal Open Market Committee (FOMC) announced it is maintaining the federal funds rate range at zero to 0.25%. Federal Reserve Chairman Ben Bernanke's prepared remarks to the Senate Budget Committee were cautious regarding the outlook for the economy. He stated that there is greater evidence that a "self-sustaining recovery in consumer and business spending may be taking hold."

Economic Developments

The Institute for Supply Management reported that its index of manufacturing activity hit a six-month high of 57.0 in December. The unemployment rate fell to 9.4% from 9.8%. US average hourly earnings rose 0.1%. Average total hours worked was unchanged at 34.3. The December producer price index (PPI) for finished goods jumped 1.1% mainly due to raw materials and energy. It was the sixth consecutive monthly increase in producer prices and the largest gain in almost a year. Retail sales rose only 0.6% in December; this is the smallest monthly gain since July. The consumer price index (CPI) for December rose 0.5%, after inching up 0.1% in November. The November trade deficit narrowed slightly to \$38.3 billion from \$38.4 billion as exports grew faster than imports. The Conference Board's index of leading indicators rose 1.0% in December after rising an unrevised 1.1% in November. The consumer confidence index shot up to 60.6 from 53.3 in December reaching the highest level since May 2010 as consumers' outlook about labor market conditions improved dramatically. Gross domestic product (GDP) grew at a 3.2% annual rate. Fourth quarter growth was driven by a 4.4% increase in consumption which rose by the most since 2006. Housing starts fell 4.3% in December, the lowest level since October 2009 and the third lowest since records began in 1959. Existing home sales for December were up 12.3%. The median home price fell 1.0% to \$168,800. New home sales jumped 17.5% to 329,000 in December.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 2.58% in January and the weighted average maturity was 807 days. Small changes occurred in asset weightings. The year-to-date monthly average investable base was up approximately \$14.1 million to \$3.176 billion. Portfolio diversification continues to be sound. U.S. Treasuries represented 2% of holdings, and U.S. government sponsored enterprises accounted for approximately 31%. Mortgage-backed securities were 34%, Municipal Bonds were 2% and Certificates of Deposit represented 4% of assets. Money market mutual funds were 7%, 11% was maintained in overnight repurchase agreements and 6% was invested in Commercial Paper. Link deposits (at less than 1%), State Bond Issues (at 3%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy will consist of a combination of laddered maturities and market observation for investment opportunities that maximize income in a secure environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees, mutual fund operating expenses and fees charged by JPMorgan Chase for the Tri-Party Repurchase Agreement Program are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,219,333,113 and State Agency balances in OK Invest at \$2,176,992,020 for a total of \$5,396,325,133.



Explanation of Performance Comparison January 31, 2011

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$1,466.34. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$425,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
